# What You Should Know About Contributing to the PAC

All contributions are **voluntary**. Individuals eligible to contribute to the PAC include Envision's executive and administrative teammates (those paid on a salary basis and who have policymaking, managerial, professional or supervisory responsibilities), stockholders and the families of these two groups. Please Note:

- Contributions to the Envision PAC will be used for federal and state campaign contributions
- Federal law requires the Envision PAC to collect and report the names and addresses of individuals who contribute more than \$200 in a calendar year
- The maximum contributions per individual are \$192 a pay period and a total of \$5,000 per calendar year
- Envision Healthcare PAC contributions are not tax-deductible
- Envision will never make employment decisions of any kind based on participation or lack of involvement in the PAC









#### HOW DO I KNOW WHERE MY MONEY IS BEING SPENT?

The PAC is required by law to disclose all contributions made to candidates for office. The PAC Board will regularly report on which candidates have received PAC funds, and all of this information will be available publicly online.



#### WHY SHOULD ENVISION SPONSOR A PAC?

The reality of American politics is that political campaigns for office cost money. Many of us, including members of the PAC Board, would prefer to see less money in politics, not more. However, candidates rely on the support of donors that share their ideals in order win public office. Big insurance companies understand this; it's why they raise and spend *millions* every election cycle to support candidates who prioritize insurers over clinicians. Our position as a leading national medical group makes us uniquely suited to counter the insurer narrative and work to elect candidates who recognize the value that clinicians bring to their communities.



#### IS THERE A RECOMMENDED CONTRIBUTION AMOUNT?

For clinicians, we recommend a contribution of \$50 per pay period. We also understand that many of you may want to contribute less; some may want to contribute more. There is no minimum, but there is a maximum - no team member is allowed to contribute more than \$5,000 per year (or \$192 per pay period).



## ARE THERE BENEFITS TO JOINING THE PAC?

Envision provides small tokens of appreciation for joining the PAC (none of which impact employment opportunities in any way). Enrollees will receive an Envision PAC branded welcome gift, regular Government Affairs updates and invitations to exclusive PAC Member only events, such as future calls with Members of Congress. More perks will be added as the PAC grows over time.



### HOW DO I JOIN?

We strongly recommend making your contribution on a per pay period basis, as this aids in projecting available funds through the election cycle. Any contribution amount is appreciated, but to be eligible for the welcome gift, a minimum contribution of \$5 per pay period is required.

Contributions to the Envision Healthcare PAC are completely voluntary.
